From same Northwest corner of North Ave and Sheffield head south crossing North Ave with a 40 ft path for approximately 30ft past south curb than continuing south on west side of Sheffield locating EOP to ROW pass first alley on east side of North Ave. From there head east crossing North Ave with a 40 ft path and continuing into alley locating width to first pole on south side 20 ft radius. Also again from same original northwest corner of North Ave and Sheffield head east crossing North Ave with a 40 ft path to east side ROW of Sheffield. From there head north on east of Sheffield Ave locating EOP to ROW pass first alley. From there head east in alley locating width to fourth pole on North side 20 ft radius.
