ALONG 43RD STREET MOST OF THE LOCATIONS CAN BE FOUND IN BOTH THE EB AND WB TRAVEL DIRECTIONS WITHIN A 100 FOOT RADIUS OF EVERY CROSS STREET. THE PROPOSED LOCATIONS ALONG PRAIRIE AVE, CALUMET AVE, MARTIN LUTHER KING DR, VERNON AVE, VINCENNES AVE, FORRESTVILLE AVE, LAWRENCE AVE, CHAMPLAIN AVE, LANGLEY AVE, AND EVANS AVE THERE ARE APPROXIMATELY 2 LOCATIONS WHERE ONE IS NORTH OF 43RD STREET AND THE SECOND IS SOUTH OF 43RD STREET WITHIN 250 FEET OF THE CORRESPONDING INTERSECTION.

AT THE COTTAGE GROVE INTERSECTIONS WITH 42ND PLACE, 47TH PLACE AND COTTAGE GROVE – ONE LOCATION WITHIN 225 EAST AND TWO LOCATIONS WITHIN 75 FEET NORTH AND SOUTH, WITH ONE LOCATION IN THE SB COTTAGE GROVE TRAVEL DIRECTION HALFWAY BETWEEN 42ND PLACE AND 43RD STREET.

AT THE COTTAGE GROVE INTERSECTIONS WITH 44TH STREET AND 45TH STREETS - TWO LOCATIONS ARE WITHIN 225 FEET EAST AND WEST AND TWO LOCATIONS WITHIN 75 FEET NORTH AND SOUTH, WITH ONE LOCATION IN THE NB COTTAGE GROVE TRAVEL DIRECTION HALFWAY BETWEEN 43RD STREET AND 44TH STREET, ANOTHER LOCATION IN THE SB COTTAGE GROVE TRAVEL DIRECTION HALFWAY BETWEEN 44TH STREET AND 45TH STREET.
