Excavation for retaining wall construction will be to depths of 15 feet and Bridge Abutments will include installation of drilled shaft foundations and earth retention systems to a depth of up to 50 feet. The Job includes additional excavation under 3 opening permits at 71st, 69th and the alley West of the CSX Right of way between Marquette and 68th St, dig tickets for these public way opening permits have been submitted and processed in addition to these private dig ticket requests.
