Begin approximately 70ft before the advanced warning sign "Ramp Meter Ahead", where pavement and concrete pavement are marked "Meade Bore". Locate grassy area between the two ramps, approximately 180 ft North of the "Meade Bore" mark and approximate 330ft going south toward the existing ramp meter posts. Also mark Mark the pavement between the pink "Meade Bore" paint, to the other side of the concrete barrier wall. From the west side of the concrete barrier and ramp, locate a path heading south along the ramp toward the existing ramp meter posts for approximately 370ft. Locate a 15ft wide path going across both ramps starting at the pink paint "Meade Bore" near the service meter pedestal and the ramp meter posts. Once on the east side of the off ramp, please locate a 30ft path approximately 200ft heading east along the ramp curve to the existing handholes near light pole CL5.
