Guide: Per Sections 10-28-281 et seq. of the Municipal Code, a CDOT Construction Canopy Permit is required for any temporary canopy (pedestrian protection structure) installed over the public way for construction purposes. This application form must be completed **only for construction-related canopies** (not for decorative or seasonal canopies) and submitted with all required documents. There is no application fee for a construction canopy license. Submission: Completed applications and attachments are accepted **via email or in person only** – online portal submission is *not* available for canopy permits (submit by email to CDOT Public Way Permit Office or deliver to City Hall, Room 905).

#### I. CERTIFICATE OF INSURANCE REQUIREMENTS

#### TO ALL APPLICANTS FOR PUBLIC WAY PERMITS:

Effective January 1, 1995, each applicant for a public way permit will be required to:

- 1. Furnish a certificate of <u>Comprehensive General Liability</u> insurance including an endorsement that reads "City of Chicago is an additional insured, as their interests may appear". <u>Minimum Limits of Liability:</u> \$1,000,000 per occurrence.
- 2. Where applicant uses a motor vehicle (any type), in the conduct of business including the use of said vehicles on boulevards, or requires a permit for the parking of said vehicle or vehicles on the public way, applicant will also be required to furnish a certificate of automobile insurance including an endorsement that reads "City of Chicago is an additional insured". Minimum Limits of Liability on motor vehicles, \$1,000,000 per occurrence.
- 3. All policies must be written by Best "A" rated companies licensed to do business in Illinois.
- 4. An original and one copy of each certificate in question should be sent to the City of Chicago. The certificate holder is:

5. Upon receipt and approval of your certificate of insurance, your application for a public way permit will be approved.

#### III. REQUIRED DOCUMENTS CHECKLIST

Please **attach the following documents** to this application (new or renewal) – *incomplete submissions* will delay processing:

- Structural Engineering Drawings & Calculations Detailed canopy plans stamped by an Illinois Licensed Professional Engineer, clearly indicating the canopy type (rolling vs. stationary; heavy vs. light duty) and including all relevant structural load calculations (live load, dead load, impact load, wind load, etc.) to demonstrate compliance with City standards. (Required for all new canopy designs or if updating a previously approved design.)
- Certificate of Insurance (COI) Proof of current insurance meeting CDOT requirements:
   Comprehensive General Liability coverage of at least \$1,000,000 per occurrence, with the City of Chicago named as an additional insured on a primary, non-contributory basis. The COI must be current through the license period and include a clause requiring 30-day notice to City of any cancellation.
- Note: There is no fee to apply for or renew a Construction Canopy license. Unlike dumpster
  permits which incur per-placement fees, the canopy license has no upfront cost. However, public
  way use fees or occupancy fees may apply depending on the duration/area of sidewalk occupied
  by the canopy, per City ordinance. (No payment is due with this application.)

After submission, CDOT will review the application for completeness and compliance. You will be notified if additional information is needed. Licenses for Construction Canopies will be issued upon approval of the application and accompanying documents, at which point you may proceed to obtain individual site permits for canopy installations. All construction canopies must be installed and maintained in accordance with CDOT regulations and must be removed promptly upon completion of work or permit expiration.
